**AN ORDINANCE VACATING CERTAIN ROAD PROPERTY
LOCATED IN SECTION 29, T.19N, R2E, BOISE MERIDIAN,
ADAMS COUNTY, IDAHO**

WHEREAS, Eric Higgins filed a Petition to vacate certain property hereinafter referred to in Exhibit A located within Adams County, Idaho; and

WHEREAS, notice of hearing to receive public comment on the proposed vacation was published once a week for two successive weeks in a newspaper of general circulation within Adams County, Idaho; and

WHEREAS, the public hearing was held June 16, 2008 and any objections voiced as to vacating of the roads more particularly described in Exhibit "A", have been satisfied;


